GENERAL USE GUIDE

This product can be mixed with most fertilizers and chemicals. Use as part of a complete turf fertility program. A compatibility test should be performed prior to use. Shake product prior to use. Maintain agitation during mixing and application. For foliar applications delay irrigation or mowing for 12 to 24 hours.

Golf Course Greens	Apply 1.0 to 9.0 fl oz per 1000 sq ft in enough water to provide sufficient foliar coverage. Repeat application every 7 to 14 days. Transition and warm season turf may require higher rates.
Golf Course Tees and Fairways Sports Turf	Apply 1.5 to 9.0 fl oz per 1000 sq ft in 0.5 to 2.0 gal per 1000 sq ft of spray solution. Repeat application every 2 to 3 weeks.
Residential and Commercial Lawns	Apply 1.0 to 5.0 gal per acre in 25 to 88 gal per acre of spray solution. Use lower rates if daytime temperatures exceed 85 degrees or if turf is exhibiting symptoms of drought stress.
