DIRECTIONS FOR USE

SMS 300 + K-Mone Pellets are to be applied with a hose-end applicator during hand watering or syringing. Apply throughout the year with no phytotoxicity to all types of turf grasses, annuals, and perennials. SMS 300 + K-Mone Pellets are an excellent tool to be used after chemical applications that are required to be watered in.

SMS 300 + K-Mone Pellets will dissolve within one hour at water pressures of 90 to 120 PSI. The rate at which an individual SMS 300 + K-Mone Pellet dissolves is determined by water quality, temperature, pressure and flow rates.

The flow of water through the hose-end applicator should follow the molded arrow. Please note some hose-end applicators have the flow opposite the molded arrow.

TURF

Insert one SMS 300 + K-Mone Pellet into the hose-end applicator and apply to 12,000 ft² during hand watering or syringing once every month.

SOD INSTALLATION

Apply one SMS 300 + K-Mone Pellet to 8,000 ft² at installation and follow-up with the normal turf application rate.

HORTICULTURE

Apply one SMS 300 + K-Mone Pellet to 8,000 ft² at transplant and at bud set for best results.
