6. HEALTH HAZARD DATA

7. PRECAUTIONS FOR SAFE HANDLING AND USE

ACTION TO TAKE FOR SPILLS/LEAKS: Contain spills by diking with dirt, sand or other absorbent material. Rope off area to prevent inadvertent spread of spill.
